AUD \$125 (inclusive of gst) for each additional metal transportation thereafter.

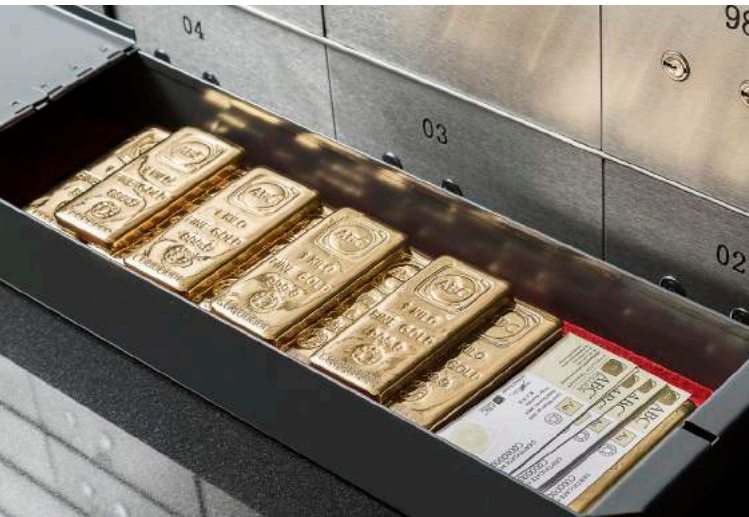
